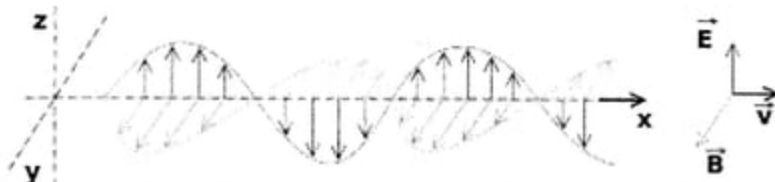


The Advantage of Free Electron Transfer over Coherent Electron Accumulation

Utilizing the fundamental [properties] of the function of $F=1/T$, (and) it's "functional purpose", that of RADAR, (*R.F. Energy transmitted in the opposing plain of polarization of a given electromagnetic energy field*);



creates a ["Transmitted Energy Source"], independent of the Parent (*Transmitter*) (or) the Child (*receiving*) device]; Thus "Energy transmitted between two points free from the bounds of cables"; where the inverse function of the transmitting gate provides the collection point of the original transmitted energy; Ergo, "To capture the free electrons bound to the E.M. of [ANY] transmitted R.F. source; more commonly known as "the conservation of Electromagnetic Energy by induction", where the photonic discharge is proportional to the transmitter, and or, the receiver.

$$p = \frac{E}{c} = \frac{hf}{c} = \frac{h}{\lambda}.$$

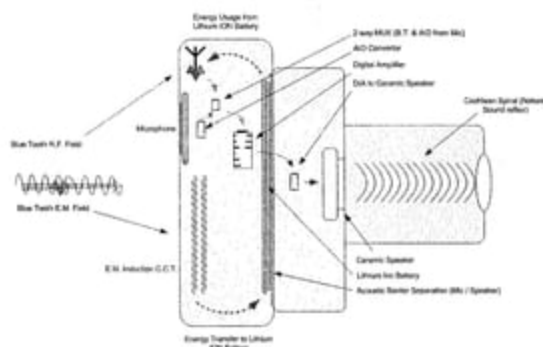
The R.F. Energy can be represented by the electron flow of a "Blue Tooth" device, showing in advance, proof of concept; applying $F=1/T$ allows for an infinite number of R.F. sources to be combined at the "Harmonic & Sub-Harmonic" wavelengths; This is represented by the IEEE standard of 802.11 (Group A to n); that of "more than one frequency being used to transmit to a group of unknown devices", [and] The telecommunication protocols, but not limited to 3G, Lite, and Edge; in fact, [ANY] R.F. energy source can be re-captured as a free electron given the right size of collector, where the collector is a harmonic monopole of the wave length of the transmitting device.

Extending function, that of energy for delivery; Ergo, "Coherent electron accumulation, this method of electron delivery is now redundant and surplus to the requirement of the delivery of the electron flow to [ANY] "electron [DEPENDANT] device";



"Without question", and with full acknowledgement, this document could [NOT] have been written without the dedicated support and input of Domagoj, Danijel, and myself (Nigel); Where the "Brilliance" of the utilization neobidium magnets (Domagoj), and the "Wisdom" of a "common goal" (Danijel), combined with unparalleled faith within "each other" has allowed P.E.T. to be fully documented.

(1). As referenced, (ref: (1)), "The North ~ South" conditional state of an electromagnetic field, where, the flow of E.M. (electrons) is bound by the physical separation of the distance between the origins of the "North ~ South" condition; this best represented by the "Earth's" Electromagnetic field.

(2). The geometrical and conditional states of a "TORUS", (a circle wrapped around itself), creates an "endless" line in both the "x" axis and the "y", creating a state of infinity about itself, and, can be expressed as $[Infinity = ((x^i) * (y^i))]$



The physical property verse's the geometrical property results in an "object" that when viewed from [all] angles looks something like a doughnut. Where the "North ~ South" conditional state no longer exists.

(3). A persistent North ~ South "attraction" condition results in the perpetual transfer of Electromagnetic Ions (or) (E.M.I.); Electromagnetic "Electrons" reside within either the "North" or the "South" components of the "North ~ South" condition, and [NOT] at the Ion transfer point, that of a NON conditional "N><S" merger.

(4). Of reference (3), the speed of an electron ($3*10^8$)M/s; this becomes the ION transfer speed at the [N><S] condition of a nonexistent point; infinite ion release from a non-moving body. All [Electrons] are flowing North to South, and South to North, and are being converted to IONS at the intersection of the North ~ South axis of "Zero"

(5). Creating a [GAP] (however so small), between the North ~ South condition will create a "SPARK", or a DISCHARGE of Ions, (converted to electrons) on contact with Earth, (or grounded). This creates a "Ground circuit" more commonly referred to "electricity"

(6). As [NO] energy was used in the creation of the release of the Ion, a perpetual state occurs of "FREE ION / ELECTRON" discharge.



(7). All E.M. fields also contain an R.F. field in the opposing plane of polarization, and all R.F. and E.M. are subordinate to its own harmonics; as expressed by the dynamics of mono-pole and di-pole constructions.

Therefore if "Two" bodies are proportionally represented by their "Ratio" of their harmonic, it is possible to create a "Torus" whose shape and size is a perfectly proportion to the harmonic of the Earth's Electromagnetic field, Ergo, A transfer of E.M. energy from the Earth's E.M. field to that of the Ratio'ed Torus.

(8). Using an example of ratio's Earth 1,000,000 (Units), and the harmonic size of the Torus to be 1 (Unit) (at ZERO POINT), a 1,000,000:1 transfer rate of the flow of election persists. (A self-charging energy source).

(9). Of point [6] speed and release, merged with point [8] create a [P.E.T.] device; and when "grounded" as at reference [4], an electrical circuit is created (locally).

(10). Utilizing the 1,000,000:1 of the harmonic ration, and, the definition of a Torus, that of $I = ((x^i) * (y^i))$ results is the basic output of the generic input to be:

Output = $(1,000,000:1) * ((x^i) * (y^i))$ or to "Dimension" the TORUS as 3 Meters by 1 Meter results in:

Output = $(1 * 10^6) * ((3^i) * (1^i))$ or

Output = $(1 * 10^6) * ((3)^{(i^2)})$ or

Output = $3,000,000^{(i^2)}$ Units where (i^2) is greater than $(3 * 10^8)!$
